

## **Community Partnerships and Available Unused School Space**

Bluewater District School Board's (BWDSB) primary purpose in carrying out its Multi-Year Strategy Plan is to support student achievement and well-being. It further recognizes that cooperative and collaborative partnerships with community partners are part of the foundation of a strong, vibrant and sustainable publicly funded education system.

Annually, BWDSB hosts a Community Planning and Partnership (CPP) meeting. Through consultation with stakeholders, it was decided that this year's meeting will be held virtually on April 9, 2024 from 2:00 - 4:00 p.m.. As part of the CPP meeting and in accordance with Administrative Procedure 2360-D Community Planning and Partnerships, information regarding unused space in open and operating schools, that is not surplus, but is available for partnerships will be provided to potential partners through the following notification process. A resolution of the board will support this process by:

- Posting information on Bluewater District School Board's website regarding new builds, significant renovations and any space that is available for partnerships. This information is to be updated annually in the case of space in existing schools and as needed in the case of co-building opportunities.
- Following newly released Ontario Regulation 374/23: Acquisition and Disposition of Real Property

Attached as Appendix A is a listing of BWDSB schools with less than 70% utilization based on 2023-2024 estimated average daily enrolment (ADE) that could potentially support a community partnership. Schools with utilization less than 60% are strong initial candidates for community partnership opportunities. The criteria identified in section 2.6 of AP 2360-D provides additional considerations when determining the appropriateness of community partnership within BWDSB schools.

As the board continues to see an overall increase in enrolment, the number of schools reported with potential unused space has decreased from 18 schools in 2019. Currently, there are eleven schools that have available unused space to accommodate an appropriate community partnership.

In addition, BWDSB is currently engaged in building two new replacement schools: a JK-8 school in Markdale to replace Beavercrest Community School and a grade 7-12 school in Kincardine to replace Kincardine District Senior School.

We encourage interested groups, municipalities and others that would be interested in a community partnership to contact board staff regarding opportunities and to participate in the meeting held April 9.

## Recommendation:

That the Business Committee of the Whole recommend to the board that it approve the list of schools with available unused space that could be made available for appropriate community partnerships.
